The role

Overall Duties

- Guiding and advising the board in the approval of budgets, accounts and financial statements, within a relevant financial policy framework.
- Keeping the Board informed about its financial duties and responsibilities.
- Chairing a monthly finance committee.
- Advising on the financial implications of The Goodwash Company CIC strategic and operational plans
- Ensuring proper records are kept and that effective financial procedures are in place to provide assurance to the Board of the company’s financial integrity and to safeguard resources
- Ensuring that a realistic budget is produced which meets The Goodwash Company CIC needs and that there is an appropriate reserves policy.
- Monitoring the financial health of the Goodwash Company CIC reporting regularly at Board meetings.
- Overseeing the production of budgets and necessary financial reports / returns, accounts and audits.
- Liaising with relevant staff and Board Members to ensure the financial viability of the Goodwash Company CIC.
- Liaising with external auditors as required.
- Ensuring that The Goodwash Company CIC has an appropriate investment strategy.

Knowledge and Experience

The Non-Executive Director does not require any previous social business experience, but will need to demonstrate extensive experience of operating at a senior financial level. Having an understanding of providing strategic direction, and knowledge of governance and how boards should add value. The Non-Executive Financial Director should be able to help lead The Goodwash Company CIC through a period of change and growth, and demonstrate a thorough understanding and appreciation of the issues facing a complex and developing social business in an ever changing and highly competitive environment.
